

## ETFC Membership Application Form (Updated July 18, 2018)

### Member Understandings and Commitments:

By applying for a new membership and/or a membership renewal, a member agrees and commits to: following the policies, rules and expectations established by the Club (as revised from time to time) with respect to its properties, meetings and other events; to conduct him/herself in a respectful, courteous and honourable manner on Club properties and at Club events; to respect the needs and privileges of other members regarding the Club's shared facilities; to respect and take proper care of the Club's facilities; and in general to represent the Club in a positive manner.

I agree that the Club Executive may revoke or deny my privileges to access or use the Spring Lake properties, or may revoke my membership and/or refuse to grant Club membership in future, should the ETFC Executive deem my actions or behaviour (or that of guests for whom I have responsibility) to be inconsistent with Club expectations. In such an event, should I have access to a Club Gate Key to the Spring Lake properties, I agree and commit to return such key promptly to the ETFC (within 14 days of being notified of my loss of privileges). I understand that the ETFC does not make reimbursement of any member related fees already paid, but will reimburse the Gate Key Deposit if the key is physically returned to the Club Gate Key Contact at their home within the specified 14 day period from such notice.

The ETFC owns property on Spring Lake. As part of the normal privileges of Club membership, a member may seek (for a non-refundable fee, plus a refundable key deposit) to use one of the Club's Gate Keys for access to and use of the Spring Lake properties and facilities. Such usage must be in accordance with the requirements and expectations identified in the ETFC Spring Lake Property policies and rules established by the Club. For Family memberships the spouse may also request a key with the payment of a separate fee and deposit. Gate keys will not be mailed.

### Notes:

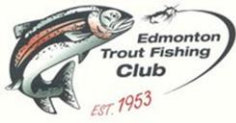
- Regular - single membership, age over 18
- Youth - single membership, age under 18
- Family – spouse or common law partners, and all children aged under 18 in the same household
- (Name) first member in household over 18
- (Dependant) – spouse, or common law partner of first member in household over 18 and any children in household under 18
- (M/F) Gender- Male / Female, gender for all members is required for AFGA
- (YOB) Year of birth for all members is required for AFGA (member insurance)
- Life members will have their club memberships and AFGA membership fees paid by the ETFC upon completion of this form.
- **If paying by cheque, make your cheque payable for all fees to: Edmonton Trout Fishing Club.**
- We are asking for any boats stored at Spring Lake that you request and place an identifying sticker on your boat. Any other members who simply want a sticker you can request a sticker as well. There is no fee for this. This will help us to identify club member boats from non-member boats as this question has come up in the past.
